MISSOURI VOTERS' BILL OF RIGHTS

You have the right to vote - it's the law, and you have the proof in your hands! You can bring this bill of rights with you into the poll. If you feel your right to vote has been violated, please find an Election Protection volunteer or call toll free: **1-866-OUR-VOTE (1-866-687-8683)**.

1. You have the right to vote if you are in line when the polls close at 7 p.m. §115.407.

2. You must present **identification** in order to vote. §115.427.1. You do not need photo ID. It does not need your signature on it. You can present *any one* of the following:

•an ID card issued by a federal, state or local government authority or agency;

•an ID card from a college, university, vocational or technical school located in Missouri;

•a current utility bill, bank statement, government check, paycheck or other government document that contains your name and address;

•a driver's license or state ID card from Missouri or another state; or

•the voter registration card sent to you in the mail by your election authority.

We recommend that you bring your voter ID card with you to the polls. If you do not have one of these IDs, you can still vote a regular ballot if you are personally known by two election judges (one from each party). You have the **right to cast a provisional ballot if your eligibility can't be established.** §§ 115.427.13 and 115.430.2.

3. You have the right to assistance to help you vote, if you cannot read or write, if English is not your first language, if you cannot mark the ballot on your own, if you do not understand how the voting system works, if something is confusing, or if you otherwise need help. §115.445.3. You can ask for help from an election official, or you may bring *any* person of your choice (including a child, relative or friend) to help you before, during or after voting. The person you bring to help does not have to be over 18 or a registered voter.

4. If you are a voter with a disability you have the right to:

•an accessible polling place (if your polling place is not accessible, you have the right to be moved to an accessible polling place or curbside vote from outside your polling place);

•an accessible ballot (electronic voting machines tilt, move up and down, and are equipped with accommodations for the visually impaired); and

•jump the line and vote immediately if your disability prevents you from waiting in line.

5. **If you have moved** within the same county and have not been removed from the list of registered voters, you have the right to vote at a central polling place or at the polling place that serves your new address. § 115.165.2

6. If you make a mistake or "spoil" your ballot before you submit it, you can request a new one. § 115.439.4

7. **If you were convicted of a felony** other than one related to voting, and have completed your sentence (including any probation or parole), you have the right to register to vote and vote. § 115.133.4

8. No one is allowed to try to influence your vote within **25 feet** of the polling place. § 115.637(18)

9. You have a right to cast a paper ballot. You are not required to use an electronic voting machine.
